Editor's notes: After consulting with the WVMF compilers about numerous record high-count species reported this season, we determined it was due mostly to extensive coverage of sector 6 by two qualified field birders, and the extensive playback of mob calls. Sector 6 is a very large northern area of the circle which includes the Old Fields area and the South Branch Wildlife Management Area. This sector contains some of the best early successional habitats in the count circle – grasslands, agricultural lands, hedgerows, power lines, and other scrub/shrub habitats. Currently, the WVMF circle only has six sectors. Examples of high results from sector 6 this season include: 12 of the 14 NOHA; 10 of the 19 BAEA; 7 of the 15 WIWR; 16 of the 24 HETH; 18 of the 20 SAVS; 141 of the 302 SOSP; 16 of the 33 EAME.
