Long, decurved bill; grayish head and long grayish neck; long, dark legs; feet similar to other large wading birds such as herons or rails with long separated toes.					
Plumage: (e.g. markings, coloration, molt)  Gray feathering on head and neck with streaking on the neck. Body with brown feathers, speckled with gray or whitish feathers on back and sides.					
Description of any vocalizations, if heard:  None heard.					
Foraging along the Potomac River shoreline. Walking slowly up and down stream along the exposed mud of the shore. Seen picking up small rounded objects with the tip of its beak. Head and neck swayed forward with each step.					

Deciduous woods and brush all along the steeply sloping bank, leading down to the river shoreline, which is comprised of sand and mud. Brushy growth along the base of the slope, with some grasses and downed trees.				
Sand and mud shore area a few feet in width bordering the river.				
Circumstances of observation: (Include details of distance to bird, optics employed, lighting in relation to observer and the bird)  All three observers were standing on a wooded path at the top of the slope about 35 feet above the shoreline and about 25 to 35 feet north of the bird's location, or about 50 feet from the bird.				
I was using Nikon 8x42 Monarch 7 binoculars. Another observer, Nancy, was using 8x42 Nikon Venturer LX binoculars. The third observer, Todd Fagan is currently away from home. I will provide information about him at a later date,				
The bird was in declining daylight, with some back lighting by the river, but was nevertheless mostly well and clearly seen, though intermittently obscured by foliage.				
Previous experience with this species:  Nancy and I are both very familiar with this species and have observed it well at numerous wetland areas in Florida as recently as February 2019.				
Experiences with similarly appearing species which are eliminated by your description: (Please be specific)  Nancy and I have seen many species of heron and egret, as well as rails and cranes, which may be similar to a Limpkin, but would never be mistakenly identified as one, by us.


IMG\_7354.JPG is a general view of some of the nearby habitat.

The Limpkin was on the shore during the entire time that it was observed. It was never seen in the water.



This is where the observers were located.




This is where the Limpkin was located.
